- 3.) I am aware of the risk, hazards and dangers of personal injury, disability and/or death as a result of participation at Turquoise Acres Ranch. In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue Turquoise Acres Ranch and its owners, agents, employees, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense including attorney fees which are related to or arise out of or in any connected to my child's participation or use of the facility.

By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Turquoise Acres Ranch, its owners, agents, employees, directors and/or all other persons or entities on its behalf.
- 5.) I acknowledge that my or my child's participation in activities at Turquoise Acres Ranch is strictly voluntary. I hereby certify that I'm over 18 years of age, I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had the opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and waive and release all substantial rights that I may have and possess.
